The addition, built in 1981, consists of 12 large, private rooms, each with an ensuite restroom and central air. The original building, constructed in 1967, has 11 sets of adjoining rooms (2 rooms total), connected by a shared bathroom, plus 3 private rooms. Each room has it's own individually controlled window AC.

There is a full commercial kitchen, large-multi-purpose room, conference room, patio sitting area, reception, and two separate basements, one of which has elevator access and is finished with a break room, beauty salon, maintenance office and storage area.





Minonk is a city in Minonk Township, Woodford County, Illinois, United States. It is part of the Peoria, Illinois Metropolitan Statistical Area.




